Advocacy News from the AAO-HNS

Information from the American Academy of Otolaryngology - Head and Neck Surgery

Center for Medicare and Medicaid Services Proposed changes

As most of you are aware, over this past summer, CMS proposed multiple changes to medical charting, coding and reimbursement. However, during the public comment period, the American Academy of Otolaryngology along with other stakeholders lobbied hard against the proposed changes as they would drastically affect the way we practice and reimbursement for the work that is done.

Jim Denneny, MD, AAO-HNS Executive Vice President and CEO submitted a 26 page letter to CMS' Administrator Verma in response to the proposed changes. Some of the highlights include CMS proposal to collapse the E/M codes from 5 to 3 with the guise of some relief on the charting side. Overall payments would be reduced particularly for work currently considered for level 4 and 5 E/M codes. This concept was put on hold to undergo further study. The proposed 50% reduction in reimbursement for the 50 modifier on the same day as an E/M code was not implemented in the final rule. The Academy's research among members indicated that, if implemented, this change would have substantially reduced practice income. Although the Academy lobbied for an increase in reimbursement and a shift away from the current methodology allowing 0.5 sinus kits per sinus to a HCPCS code for the kits to bill based on the number of balloons used on each patient. The reimbursement for the kits for balloon sinus dilation were left unchanged which is certainly better than a decrease. Comments by the AAO-HNS also included responses to

mis-valued codes, quality measures, prohibition on seeing physicians in the same group on the same day and opposition to equalization add-on codes among others.

Most of the changes will not be implemented as proposed so there can be more study and input. That means that we will see these unfavorable changes circle back around at some point most likely within the next two years. Please stay aware and educated. Also, the work by the AAOHNS just on this issue has more than paid for your yearly dues. Please keep your Academy membership active. We are small in numbers as a sub-specialty but our Academy is exceedingly well respected on policy and legislative matters which has been essential keeping our interests well represented.





Emory University Hospital Midtown Campus continues to serve as our academic and clinical centerpiece. Faculty also practice at Emory University Hospital, Children's Healthcare of Atlanta's Egleston Hospital, Grady Memorial Hospital, the Atlanta VA Medical Center, the Emory Sleep Center, and the Emory Aesthetic Center.

Annual AAO-HNS Meeting

We were delighted the AAO-HNS selected Atlanta to be the host city for our most recent Academy meeting. We had a wonderful meet-and-greet with alumni as well as prominent national and international otolaryngologists at The Center for Civil and Human Rights by Centennial Olympic Park. Over 150 guests were in attendance and it was terrific to reconnect with so many guests.

Our department continues to be involved on a national stage with attending physicians and trainees involved as instructors, moderators, podium presenters, and poster presenters. Faculty within all divisions were involved as instructors during the meeting. I'm also especially proud of the efforts of Drs. Adam Klein, Arturo Solares, Esther Vivas, Carrie Flanagan, Oswaldo Henriquez, and Kara Prickett who organized "Emory en Espanol" a course for visiting physicians just before the AAO meeting and was conducted entirely in Spanish.

Emory Proton Therapy Center

Years of preparation and construction are soon to come to fruition with the opening of Emory's new Proton Therapy Center in Midtown Atlanta, just two blocks from our academic headquarters at Emory University Hospital Midtown. This center - the only of its kind in Georgia - will open its doors for treatment in late 2018 with five treatment gantries. This center

ERGO - Emory Research Group in Otolaryngology

As part of our tri-partite mission, ERGO was formed in 2016 as a means to coordinate research efforts within the department and to advance research practices within our field. Currently lead by Drs. Raj Dedhia (MD, MSCR), Nikhila Raol (MD, MPH), and Joshua Levy (MD, MPH), quarterly ERGO meetings provide a discussion forum for future and completed resident research projects and for faculty to provide didactics on clinical research skills to trainees.

Since it's formation, it's identified over \$8M of research grants obtained by faculty with over \$3M of that coming for faculty serving as a primary investigator for the grant. As our department continues to grow, I'm delighted to report our research efforts are also growing in step.

Residency and Fellowship Training

Under the guidance of Residency Director Sarah Wise, we are in the midst of our residency interview season. Applications are unbelievably strong this year and we hope to announce another successful residency match of four impressive trainees in Spring 2019.

We will also continue to offer fellowship training in Head & Neck Oncologic Surgery, Laryngology, Sleep Medicine and Sleep Surgery, Pediatric Otolaryngology as well as two fellowships in Rhinology.

Our graduates continue to thrive; one of our most recent residency graduates entered private practice and three matriculated into fellowship training programs in head & neck surgery, plastic surgery, and pediatrics. Our fellows have been equally successful by going on to join academic practices across the US and Canada.

CMS Heeds AAO-HNS Concerns on 2019 Physician Fee Schedule

On November 1, 2018, CMS released a final rule implementing changes to the 2019 Medicare Physician Fee Schedule. In response to AAO-HNS advocacy and coordinated efforts across the house of medicine, CMS opted to rescind its proposal to apply an MPPR/Modifier 25 reduction for procedures reported on the same day as an E/M service. In addition, the agency delayed and modified its broad-reaching proposed changes relating to coding and payment for E/M services for new and established patient office visits. Beginning in 2021, which allows more time for stakeholder input, CMS will maintain the billing code for the most complex patients and collapse the current E/M coding system into three tiers. While the AAO-HNS continues its review of the 2,400-page final rule, James C. Denneny III, MD, AAO-HNS EVP/CEO, provided a preliminary analysis.

AAO-HNS LEADS EFFORTS TO OPPOSE AUDIOLOGY DIRECT ACCESS/PHYSICIAN STATUS LEGISLATION

AAO-HNS Leads Efforts To Oppose Audiology Direct Access/Physician Status Legislation

The AAO-HNS strongly believes a physician-led hearing healthcare team, with coordination of services, is the best approach for providing the highest quality care to patients. However, some in the audiology community continue to pursue legislation that would threaten patient safety by removing existing physician referral requirements within the Medicare program and redefining audiologists as "limited license physicians."

The Audiology Patient Choice Act (S. 2575) was introduced in the U.S. Senate by Senators Elizabeth Warren (D-MA) and Rand Paul (R-KY) in March 2018. If enacted, S. 2575 would:

- 1 provide audiologists with unlimited direct access to Medicare patients without the need for a physician referral; and
- 2 inappropriately add "audiologist" to Medicare's definition of a physician S. 2575 is essentially identical to the audiology direct access/physician status legislation (H.R. 2276) introduced last year and in previous sessions of the U.S. House of Representatives. Hearing and balance disorders are medical conditions that require a full patient history and physical examination by a medical doctor (MD) or doctor of osteopathic medicine (DO). Although audiologists are valued health professionals who work for and with physicians, they do not possess the medical training necessary to perform the same duties as physicians, nor are they able to provide patients with the medical diagnosis and treatment options they require.

More than 130 national, state, and local medical societies, including the AAO-HNS, have opposed this effort in the House and the Academy is again leading the effort opposing S. 2575. In addition to spearheading a physician community opposition letter, the AAO-HNS has activated a grassroots response through PROJECT 535, updated our "Call to Action" for sending pre-written messages to lawmakers, and launched a "virtual lobby week" in June. From the AMA House of Delegates report: Issues impacting otolaryngology

The American Medical Association (AMA) held its 2018 Annual House of Delegates (HOD) Meeting in Chicago, IL, June 9-13.

Our Academy was represented by **Robert Puchalski**, **MD**, Delegation Chair; **Douglas Myers**, **MD**, Delegate and Otolaryngology Section Council Chair; **Craig S. Derkay**, **MD**, Delegate; and **James C. Denneny III**, **MD**, AAO-HNS EVP/CEO, as Alternate Delegate.

Retrospective ER coverage denials

Retrospective denials are becoming an increasing trend among national payers. The AMA voted to work to strengthen the enforcement of federal and state laws which require payers to cover ER care when a patient reasonably believes they are in need of immediate medical attention, including the imposition of meaningful financial penalties on insurers who do not comply with the law.

Grill brush warning

The AMA voted to secure placement of a warning label on all wire-bristle grill brushes informing consumers about the possibility of wire bristles breaking off and being accidentally ingested.

Portable listening devices and noise-induced hearing loss

The AMA voted to advocate for labeling on earbuds that do not have amplitude limiters to warn of the risk of hearing loss with extended use at high volume levels for extended periods.

Compensation for pre-authorization requests

In an effort to reduce unnecessary administrative and related financial burdens, the AMA voted to petition CMS that CPT code 99080 be reimbursed by Medicare.

Physicians at the meeting also:

- * Sought to boost affordability and competition in ACA marketplaces
- * Adopted policy that puts organizational muster behind achieving health equity in the U.S. health system
 - * Agreed upon common-sense gun safety measures
 - Committed to integrating precision medicine into alternative payment models
- * Declared that drug shortages are a matter of national security.
